Other Site Characteristics

Pequeña zona acantilada situada en la costa EN de Mallorca. Está formado por materiales calizos que son continuación de una de las sierras del levante mallorquín. Las zonas más bajas están ocupadas por pinar, mientras que las más elevadas muestran el efecto continuado de los incendios y el pastoreo, desarrollandose comunidades dominadas por el ?càrritx? (Ampelodesma mauretánica). En la zona se encuentran las Cuevas de Artà, cavidad explotada turísticamente, a las que se accede por una carretera costera

4.2 Quality and importance

La especie que justifica su declaración como ZEPA es el Cormorán moñudo, que mantiene una colonia importante en los acantilados. También nidifica el Halcón peregrino y otras especies del Anexo I de la Directiva 79/409/CEE.
